
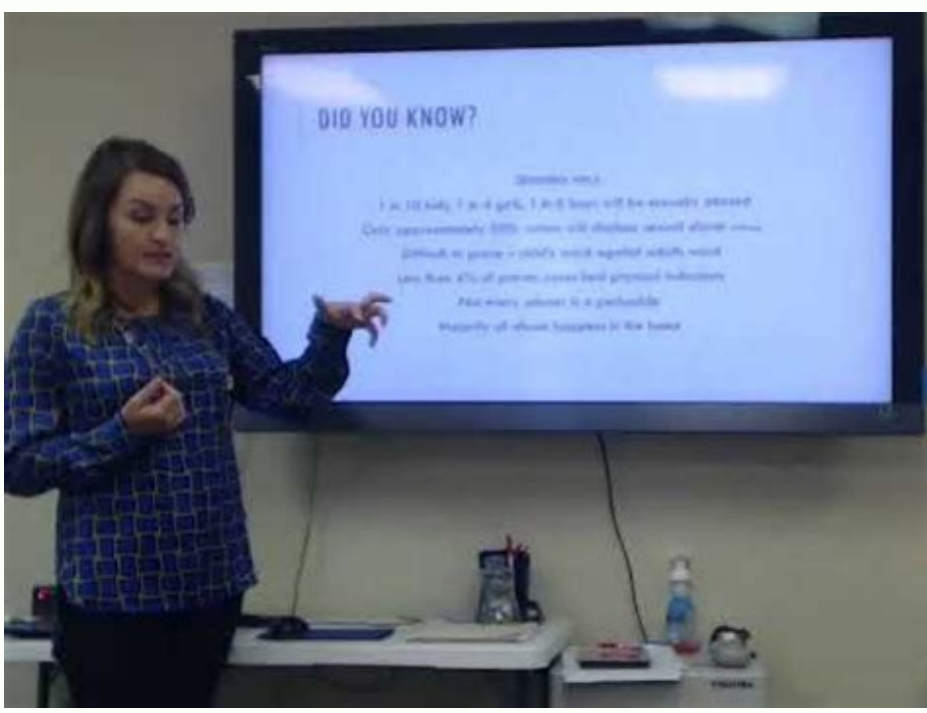

Individuals in these professions, when applying initially for licensure or a limited permit, or for the renewal of a New York State license or registration, must provide documentation of having completed the coursework or training through a Department-approved course. As of that date, individuals in these professions, when applying initially for licensure or a limited permit must provide documentation of having completed the coursework or training through a Department-approved course.* Effective July 1, 2014, this requirement also applies to licensed behavior analysts and certified behavior analyst assistants. Within ten days of coursework completion, the approved provider from whom you obtain the training is required to issue you two copies of the Certification form. All persons applying for a provisional or permanent certificate or license valid for administrative or supervisory service, school service, or classroom teaching service must have completed the two hours of coursework or training. An individual who completes an out-of-state medical program unregistered by NYS who then receives training in a NYS residency program has not met the training requirement and must take additional training from an approved provider. This requirement applies to: Chiropractors, Dental Hygienists, Dentists, Optometrists, Physicians, Podiatrists, Psychologists, and Registered Nurses. Students graduating from such programs on or after the effective dates are not required to take additional training and are not required to receive a Certificate form or submit documentation. Some of the reasons for not reporting were: Confusion or misunderstanding about reporting laws and procedures; Lack of or awareness of danger signals / clues. Students who graduate from these programs on or after 1 September 1990 are not required to take additional training and is not required to receive a certification form and send documentation. You may be suitable for an exemption if the nature of your practice is such as not to have a professional contact with ages less than 18 years old and you have no contact with people of 18 years or more with a handicap condition residing in a school of residential care or in the structure. Immunity from the liability The requested journalists are given immunity from the New York State Social Service Law responsibility, section 419: any person, official or institution that participates in good faith in the implementation of a report, to the intake of photographs or removal or holding of A suspicion child can be abused or neglected, they must have the immunity from any liability, civil or criminal, which could derive from these actions. Exemptions The law exempt from training an individual who can document, to the satisfaction of the department, which is no need for formation based on the nature of the practice of her. Furthermore, no school, school official, supplier of childcare, assistance supplier for the assistance or supplier of mental health facilities must impose any condition, including preventive approval or preventive notification, on a member of their own Personal obliged to report abuses or abuse of the child suspected. Because the laws of state change based on the needs of its residents, the state legislation of New York can include further professionals over time. From 1 September 1990, Programs registered by NYS that lead to licensing or certification in one of the above areas covered by the legislation have been required to include training in the identification and reporting of child abuse and ill-treatment. However, Residency programs, which are taken after receiving licensure, are not required to include such training. The penalties for failure to report child abuse or ill-treatment/negligence by bonded journalists addressed in the New York State Social Service Act, Section 420: any person, officer or institution required by law to report a suspected child abuse suspicion or misconduct/negligence which does not voluntarily fail to do so, will be guilty of an A-class offense. Any person, officer or institution required by this title to report a case of suspected child abuse or ill-treatment/negligence which he knowingly and willfully fails to do so must be liable to civil law for the damage caused by such failure. Effective January 1, 1989, the Education Act requires certain individuals, when it initially applies for licensure or limited permission, to provide documentation of having completed two hours of courses or training related to the identification and reporting of child abuse and ill-treatment. Therefore, the training received during residence does not meet the NYS training requirement. From that date, individuals in those professions, when they initially apply for the license or a limited permit must provide To have completed the courses or training through a course approved by the department.
